TERMS AND CONDITIONS OF MEMBERSHIP

- 1. No refunds of membership will be made if a member terminates their membership early.
- 2. The club management reserves the right to suspend a membership due to illness or similar reasons, however, this will be at the discretion of the management.
- 3. The management reserve the right to refuse membership.
- 4. Members paying their subscription by standing order are responsible for any defaults in payment, should this occur then membership will automatically be suspended until payment has been made.
- 5. Members are reminded that a reasonable standard of dress is required at all times.
- 6. Starting Regulation All players are required to book tee times via the online system and to check in with the pro shop prior to commencement of play.
- 7. Green Staff Players must give priority to the green staff at all times
- 8. Mobile Phones Most members and visitors come to the club to get away from business and to enjoy their leisure without unwanted intrusions, however respectful usage of mobile phones in the clubhouse and on the course is permitted.
- 9. In the Clubhouse Bar & Restaurant No golf shoes or wet and muddy clothing allowed at any time. (Golf shoes are allowed in the changing rooms and Pro shop only).
- 10. Slow Play If more than 1 clear hole develops between you and the next group in front, you must allow the following group to play through.
- 11. Course Management, Local rules & notices Local rules are shown on the scorecard. Temporary local rules, and safety notices are displayed on the notice boards in the changing rooms. Please read them both before going out to play.
- 12. Safety Safety on the golf course is the responsibility of all players.
- 13. Buggies & Trollies Buggies are available to hire from the pro shop. Buggies however are only permitted to be driven by those over the age of 18. The use of buggies not hired from the Club is forbidden unless prior permission is granted. Any damage to a buggy and any damage or personal injury caused by a buggy will be the responsibility of the hirer and /or driver. The Club accepts no liability for any such damage or injury. The hire of buggies should be paid for prior to your round of golf.
- 14. Security The Club cannot accept responsibility for any personal items lost or damaged caused to items including vehicles belonging to members or visitors.
- 15. Out of Bounds Entry into any neighbouring property to retrieve a lost ball is strictly forbidden.
- 16. Alcohol on the Course The consumption of alcohol whilst on the course, playing or for any other reason, is not encouraged. Any consumption must be discreet and must not be allowed to affect playing or courteous behaviour towards other course users.
- 17. Complaints Members are not permitted to reprimand any employee of the Club. Any complaint as to the behaviour of any Member of staff must be made to the Committee.
